General Rules & Information: Participants are expected to be ready for their testing time. Testing will take place in groups of 6. **Additional details will be emailed once the event closes.** Please follow all directions for parking. We have a designated potty area on the property. **Clean-up** after your dog. Exhibitors must have control of their dog at all times. Dogs **MUST** be on a leash or crated during the event. Every exhibitor must sign a Hold Harmless Agreement. Exhibitors will crate out of their vehicles.

Dogs Eligible to Enter the ATT Test: Dogs who are at least 1 year of age are eligible to take the ATT and must either be AKC or FSS registered or listed with Canine Partners or have a Purebred Alternative Listing number. Dogs that are spayed or neutered may participate. Dogs must be able to perform whole categories of the test (such as hearing auditory stimuli and seeing visual stimuli), in order to be eligible to earn an ATT title. Dogs with disabilities such as those that are blind, deaf, or have three legs are eligible to enter provided in the opinion of the evaluator they display no signs of physical discomfort and can safely complete the test. However, if a dog has multiple disabilities such that, it is unable to complete whole categories of the test (i.e. - hearing auditory stimuli and seeing visual stimuli), the dog would not earn the ATT title.

AKC Filing Fee: At every licensed and member club ATT test is held under AKC regulations, a recording fee of \$3.50 is required for every entry. The recording fee is to help defray expenses involved in maintaining the records, and applies to all entries, regardless of whether they participate. This recording fee is already included in the event entry fee.

PNW Scent Work club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **FIVE** entries will be placed on the wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to closing date. No entries may be withdrawn with a refund after closing on OCTOBER 30, 2025, 6:00pm or at the discretion of the Trial Secretary. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry minus a \$5 processing fee. Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

DIRECTION

FROM THE NORTH (from I-5) Take exit 278 onto Ehlen Rd West towards Donald. Turn Left onto Butteville Rd and drive 3.3 Miles to Broadacres RD and turn Left. Drive .2miles and turn left into the driveway, just PASSED the pine trees. Please do not use neighbor's driveway as a turn around.

FROM THE SOUTH (from I-5) Take exit 271 onto OR-219 towards Molalla. Turn left onto Newberg Hwy towards St Paul. At the roundabout, take the first exit only HWY 219 NE. turn right onto Butteville RD NE. In 2.7 miles turn right only Broadacres RD (at the store). Drive .2 miles until the end of the pine trees and turn left, do not use the neighbors as a turn around.

No entries will be accepted by phone, or fax. Entries will be accepted by email or snail mail, with payment included. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to petslove2play@gmail.com. No entry shall be made, and no entry shall be accepted which specifies any conditions as to its acceptance.
